The FHLBNY is a reliable provider of liquidity to members in all operating environments.



Custom advances are also available that include interest rate caps and floors, collars, putables, and callables. Discounted community investment advances and certain grants are also offered to our members in support of low-income housing and community economic development to help improve communities.

Year-over-year, insurance company membership in the FHLBank system and the FHLBNY has continually grown. Members are taking advantage of attractive borrowing terms — advances to insurance-company members are at all-time highs and used for various funding, including untapped emergency liquidity, spread enhancement, asset and liability management needs and acquisitions.


